- But with New Innovative idea of Crypto Mutual Fund Concept (First Ever in Crypto World)



# **BTR UNIQUE FEATURES**

#### Token Distribution Pattern

We have planned to distribute Bitether in very unique pattern as follow:



- Out of 550,000,000 BTR Tokens,10% (55,000,000) BTR will be held by company's promoters & Directors.
- 25% (137,500,000) BTR will be kept aside for distributing Bonus & Referrals.
- 2.5% (13,750,000) BTR will be used for charity. Because company believes in noble cause such as helping needy people, e.g. Medical, Education, Basic needs, etc. Company believe that if company is growing then poor people & needy people must be grown as well.
- Remaining 62.5% (343,750,000) BTR will be circulated among investors & other users.

ICO {Initial Coin Offerings} 343,750,000 BTR will be distributed via ICO using following Issuing Cycles.

#### ICO (343,750,000 BTR) Distribution:

- After completing Every Cycle, the issuance of BTR will be halved.
- So, as per cycle of Issuance, it will take 34 cycles to finish the issuance.
- To complete each cycle, it is taking 9 months, So for completing 34 cycles It will take 25 years and 6 months to issue total 343,750,000 BTR via ICO
- This issuance will be done via unique method of allocation of the company on monthly basis e.g. company can issue maximum 19,094,400 BTR via ICO, and if company gets application of say 3,00,000,000 BTR in a month then company will issue 63.65% ( i.e. 19,094,400 X 100 / 300,000,000 ) BTR to all the applicants, And their remaining amount of investment i.e. 36.35% will be given back or He/She can rollover to apply in the next month.

#### **ICO** Phases:

We have kept the distribution of BTR in three unique phases as follow:

- Phase I (Cold Constant Phase): In the first phase of ICO, the rate of BTR will be \$0.01 constant for the period of 30 days from ICO Opening Date.
- Phase II (Hot Growing Phase): In the second phase of ICO, the rate of BTR will increase gradually as per the demand increases for the period of next 100 days till the listing of BTR on exchange.
- Phase III (Variable Trading Phase): In the third phase of ICO, the BTR token will be listed in private or International Exchange, So, the rate of BTR will depend on the trading scenario.

#### Investment Bonus:

Based on the early entry into the ICO of BTR, we offer different bonus slabs for Investors:

Firstly, after the period of 130 days of ICO (i.e. **27<sup>th</sup> Jan, 2018**), the listing of BTR will be on the company's private exchange.
